The validity of the IATF 16949 1st and 2nd party auditor certificate is 3 years. After 3 years it is necessary to pass a recertification exam. Recertification is under the license of VDA QMC. Recertification exams are conducted together with the VDA 6.3 Auditor exams. Select the exam date on the "VDA 6.3 Auditor - first exam" page and send the completed IATF 16949 Auditor Recertification Application Form, page 1 and page 2, to hofmanova@csq.cz with the date of the selected exam. Only certificates in electronic form are now issued. Auditor cards are no longer issued.

Charakteristika

Requirements for renewal of IATF 16949 Auditor certificate by 1st and 2nd party after 3 years:

- 1. Deadline for submission of recertification applications:
- The application for recertification can be submitted no earlier than 4 weeks before the expiry of the certificate and no later than 3 months after the expiry of the certificate.
- 2. Provision of audits for recertification:
- Demonstrate completion of a minimum of three (3) full audits to IATF 16949 within the past 3 years.
- if the above condition is not met, it is necessary to attend a one-day retraining workshop (ID 240) it can only be attended directly at VDA QMC.
- 3. Recertification exam:
- Recertification exams are conducted together with the VDA Auditor 6.3 exams.

- Evaluation of the extent to which the applicant meets the requirements of the CSJ
- Any additional additions to the required documents
- Decision on admission to the recertification examination
- Self recertification exam:
- scenario-based audit demonstration. Preparation for the exam is 30 minutes and then 20 minutes to perform the audit in front of the exam board.
